

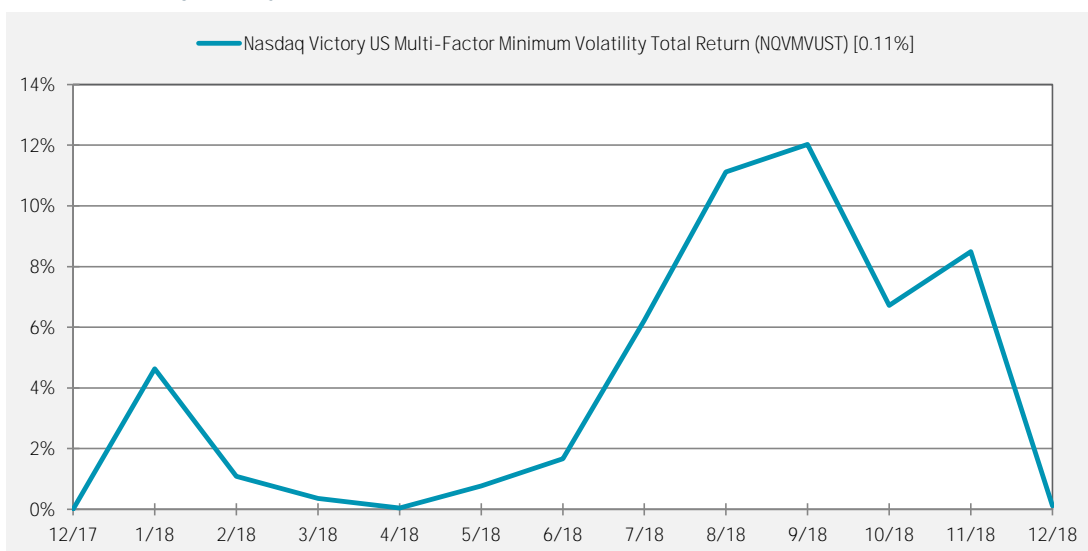


# Nasdaq Victory Multi-Factor US Minimum Volatility

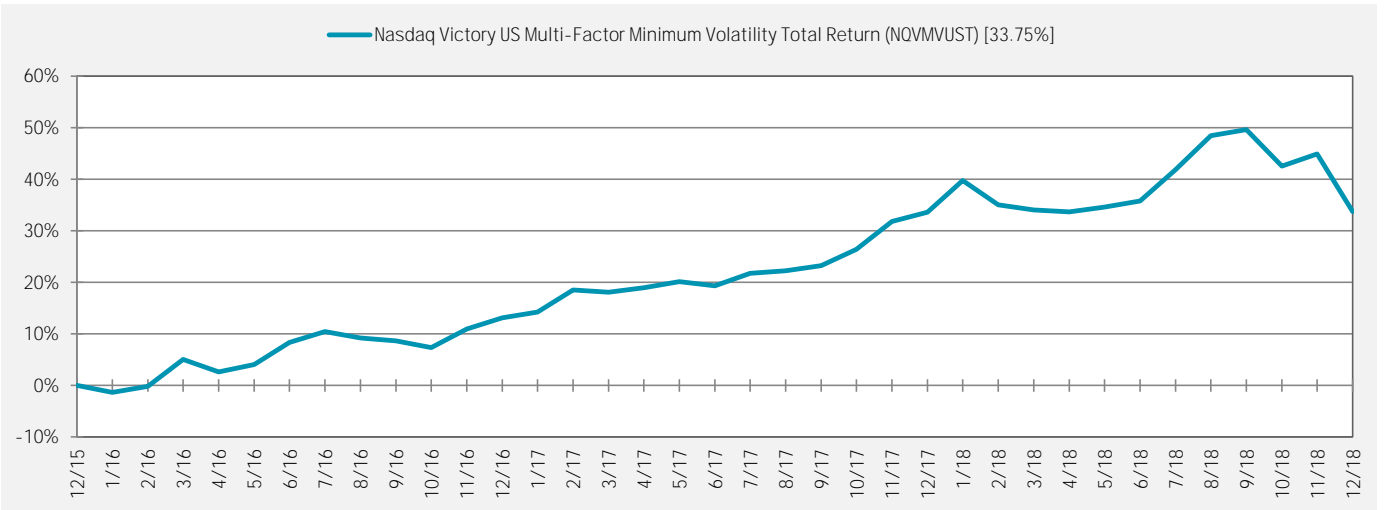

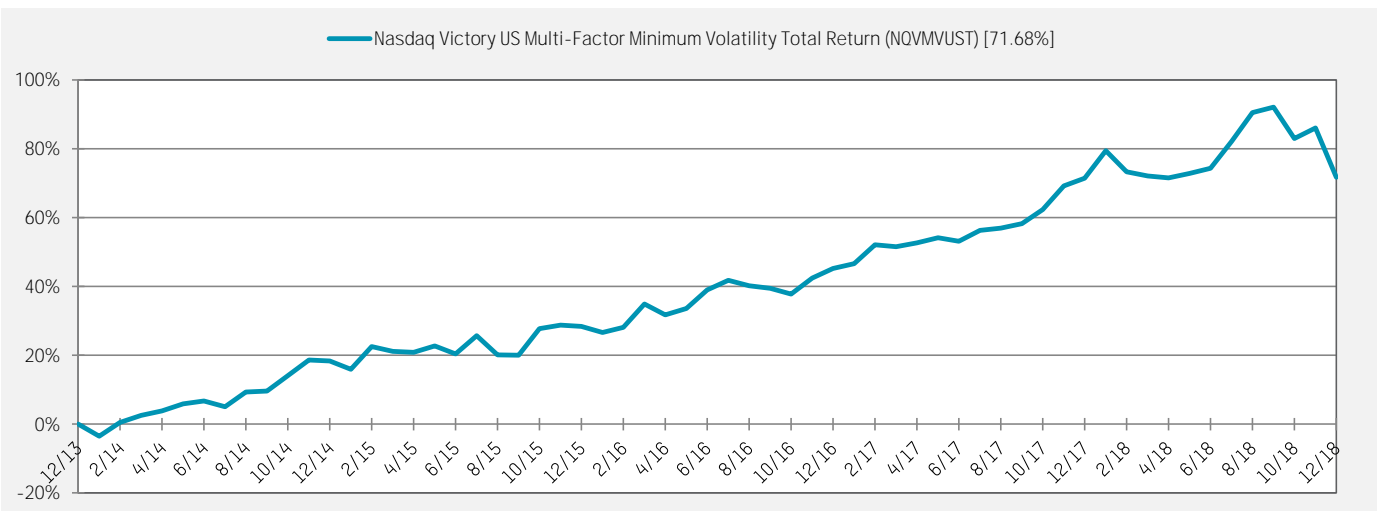

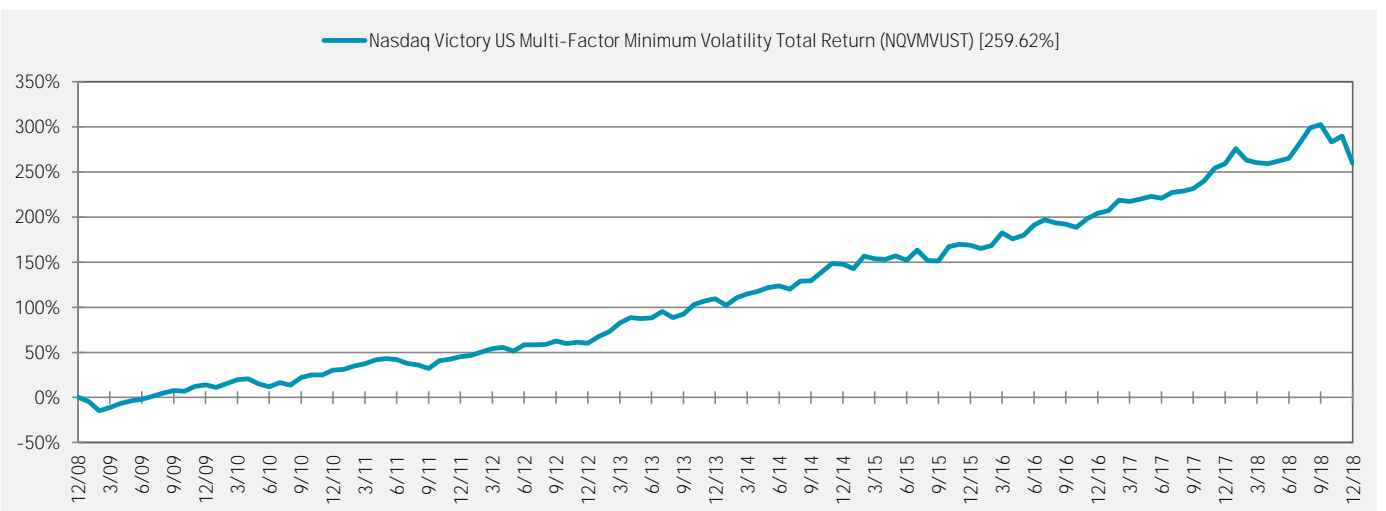
### 3-YEAR PERFORMANCE
