NASDAQ ALPHADDEX® MULTI-CAP VALUE™ INDEX

INDEX DESCRIPTION

The Nasdaq AlphaDEX® Multi-Cap Value Index employs the AlphaDEX® security selection methodology to select and weight securities from the Nasdaq US 500 Large Cap Growth™ Index (NQUS500LCV™), Nasdaq US 600 Mid Cap Growth™ Index (NQUS600MCV™) and the Nasdaq US 700 Small Cap Growth™ Index (NQUS700SCV™). The Nasdaq AlphaDEX® Multi-Cap Value Index is constructed by ranking the securities in the Indexes mentioned above separately on growth and value factors.

SECURITY ELIGIBILITY CRITERIA

Security universe

A security must be included in either the Nasdaq US 500 Large Cap Growth Index (NQUS500LCV), the Nasdaq US 600 Mid Cap Growth Index (NQUS600MCV) or the Nasdaq US 700 Small Cap Growth Index (NQUS700SCV) as of the Reconstitution Reference Date. Please refer those methodologies for further information.

Multiple classes of securities

One security per issuer is permitted. If an issuer has multiple listed security classes, the security with the highest median liquidity generally is considered for possible inclusion in the Index.

Liquidity eligibility

A security must have a trailing five-day average daily traded value of at least \$500,000 (USD) for each of the 60 trading days leading up to and including the Reconstitution Reference Date.

Other eligibility criteria

If, at reconstitution, Nasdaq becomes aware that an issuer or security will soon undergo a fundamental change that makes it ineligible, Nasdaq will remove the security from consideration. This includes

entering into a definitive merger or acquisition agreement or other pending arrangement that would make it ineligible for Index inclusion, or a filing of bankruptcy or similar protection from creditors.

INDEX CALENDAR

Reconstitution schedule

The Index Reconstitution is conducted quarterly in January, April, July and October.

Reconstitution reference dates

Unless otherwise specified, the Security Eligibility Criteria and Constituent Selection and Weighting Process are applied using data as of the end of December, March, June and September, respectively.

Reconstitution announcement dates

Index Reconstitution changes are announced on the second (2nd) business day of the Reconstitution month after market close.

Reconstitution effective dates

Index Reconstitution changes become effective at market open on the sixth (6th) business day of the Reconstitution month.

Rebalance schedule

Index rebalances occur in conjunction with reconstitutions and follow the same schedule.

Holiday schedule

The Index is calculated Monday through Friday, except on days when the Nasdaq US exchange is closed.

Index calculation and dissemination schedule

The Index is calculated during the trading day and is disseminated once per second from 09:30:01 to 16:00:00 ET. The closing value of the indexes may change after market hours due to corrections to the Last Sale Price of the Index Securities.

CONSTITUENT SELECTION

Constituent selection factors

The growth factors used for ranking eligible securities are:

- 3-, 6- and 12-month price appreciation
- sales to price ratio
- 1-year sales growth

The value factors used for ranking eligible securities are:

- book value to price ratio
- cash flow to price ratio
- return on assets

Constituent selection and weighting process

I. Securities in each size-segment of the Nasdaq US Select Size Value Indexes [NQUS500LCV, NQUS600MCV, NQUS700SCV] are ranked on the sums of ranks for both growth and value factors. A security must have data available for all growth factors to receive a growth rank and all value factors to receive a value rank.

II. Nasdaq classifies each security as either a value security or growth security. Securities classified as value securities are assigned their value ranks and securities classified as growth securities are assigned their growth ranks as their “Selection Scores.”

III. Based on the Selection Score, the top-scoring value securities, as defined below, comprise the “Selected Securities” universe.

- Top 187 securities from the Nasdaq US 500 Large Cap Value Index
- Top 225 securities from the Nasdaq US 600 Medium Cap Value Index
- Top 262 securities from the Nasdaq US 700 Small Cap Value Index

IV. Each size-segment of the Selected Securities universe is then split into quintiles of equal size based on Selection Scores. The top scoring quintile receives 5/15 (33.3%) of the universe weight and successive quintiles receive 4/15 (26.7%), 3/15 (20.0%), 2/15 (13.3%) and 1/15 (6.7%), respectively. Securities are equally weighted within each quintile.

V. Using the quintile weights for each size segment determined in Step 4, security weights are re-scaled such that the sum of large-cap security weights is 50%, the sum of medium-cap security weights is 30%, and the sum of small-cap security weights is 20%.

Constituent weighting scheme

Nasdaq AlphaDEX® Indexes are modified equal-weighted indexes.

INDEX MAINTENANCE

Deletion policy

If, at any time during the year other than the Index Reconstitution(s), an Index Security no longer meets the Eligibility Criteria, or is otherwise determined to have become ineligible for inclusion in the Index, it is removed from the Index. This includes circumstances where an Index Security is determined to be ineligible for continued inclusion in the Index due to bankruptcy, delisting, or a definitive agreement that would likely result in the security no longer being Index eligible. Please refer to **Nasdaq's Corporate Actions and Events Manual – Equities** for detailed handling of the aforementioned event types.

Replacement policy

Index Securities deleted at any time during the year other than the Index Reconstitution(s) are not replaced.

Corporate actions

In the interim periods between scheduled Index reconstitution events, individual Index Securities may be subject to a variety of corporate actions and events that require maintenance and adjustments to the Index. Specific treatment of each type of corporate action or event is described in **Nasdaq Corporate Actions and Events Manual – Equities**, which is incorporated herein by reference.

In certain cases, corporate actions and events are handled according to the weighting scheme or other index construction techniques employed. Wherever alternate methods are described, the Index will follow the “Non-Market Cap Corporate Action Method.”

Index share adjustments

Other than as a direct result of corporate actions, the Index does not normally experience share adjustments between scheduled index Rebalance and Reconstitution events.
